Begin. It is an exciting word, full of hope for new opportunities and anticipation of new successes. Beginnings don't happen once and they don't even always happen at the very start. New beginnings can happen at any time and at any age.

During the first nine months of 2016, through the commitment of our donors, the dedication of our staff and the compassion of the community, Oakland Family Services touched the lives of nearly 40,000 people through prevention, education and treatment services. These programs give children strong starts and adults new chances at the life they desire.

Oakland Family Services ensured that early childhood development and education is stressed in children's lives, right from the very beginning. Before 3 to Succeed, our early childhood initiative, identified nearly 4,000 families with children from ages 0-3, offering them both developmental screenings and key educational information that help parents engage their children. When necessary, little ones were routed to the life-changing services we provide. Helpful information on the importance of early brain development also reached nearly one million people through social media channels.

The agency continued to provide high-quality education for 192 preschoolers at the very beginning of their educational journey. Our Children's Learning Centers provide a research-proven, play-based education that prepares at-risk children for kindergarten and beyond. In fact, of Children's Learning Center students who go on to kindergarten, 96% are promoted to first grade.

Oakland Family Services also continued its focus on providing trauma-informed care, ensuring that clients who have a history of physical and/or sexual abuse or other trauma-inducing experiences are not retraumatized when they come to us for help. In addition, we began expansion of our Project Recovery Intensive Services for Mothers (PRISM) program, in order to give more moms the chance at a new beginning and their children the chance for a strong start to life. This intensive outpatient substance abuse treatment program had some impressive statistics last year: 100% of babies born to participants were drug free and no woman lost custody of her children while participating.

New beginnings do not just exist for individuals and families, though. In the first nine months of 2016, Oakland Family Services continued working toward a new beginning

of its own. As the board of directors and agency leadership looked toward the future of the agency's Behavioral Health program, the desire to tell the story of what we provide for our clients, what services we offer, became clear. As such, the agency developed a new name and logo for this line of services. We are proud to introduce you to Day One, a program of Oakland Family Services. You can read more about how we are supporting people as they begin again on page 24 of this report.

Also in the first nine months of 2016:

- + Volunteers were critical to the success of the agency. More than 220 dedicated people contributed more than 1,400 hours of time, working hand in hand with our staff to serve the needs of our clients and help Oakland Family Services advance its mission.
- + Clients whose lives were changed by the agency became spokespeople in the community, sharing emotional stories of how Oakland Family Services worked to help them.
- + Agency Ambassadors introduced people to the organization, helping them learn about Oakland Family Services' important work.
- + Our caring and dedicated staff worked to ensure a brighter future for every individual and family who walked through our doors.

This report describes the many programs Oakland Family Services offers and their impact on the individuals we serve. It celebrates all who make this work possible. Finally, it shows how Oakland Family Services, being in its 95th year of serving the community, still believes fervently in the power of new beginnings.

PROGRAMS & SERVICES

Oakland Family Services offers a continuum of prevention, education and treatment services that span the human life cycle to enrich the lives of children, strengthen families, and build brighter futures.

Examples of the impact our innovative programs had in our community in the first nine months of 2016 are:

1,400 Families

Children in more than 1,400 families will have brighter futures through culturally sensitive programs that enhance parenting skills, strengthen family relationships, and help children enter school ready to succeed.

200 Children

More than 200 children were provided with safe and loving homes, whether placed with an adoptive family or reunified with their parents.

1,400 Parents

Nearly 1,400 parents and relative or licensed caregivers attended trainings to provide children with more experiences that foster learning and development, helping children enter school with the skills they need to be successful.

450 Youths

More than 450 youths with serious emotional disturbances, and their families, learned skills to manage emotions and behaviors, so that children are able to achieve their goals at home, at school and with friends.

3,300 People

More than 3,300 people were helped to overcome issues such as depression, anxiety, grief and loss, substance abuse and troubled interpersonal relationships, improving social, family and work functioning.

4,000 Community Members

More than 4,000 members of the community and more than 750 clients of Oakland Family Services received educational materials on the importance of early brain development in a child's preparedness to succeed in school through the Before 3 to Succeed awareness campaign and initiative. Further, this information reached nearly one million people via social media.

PREVENTION

When Stephanie first came to Oakland Family Services, her foster son DiMario was hitting her, yelling at her and crying a high-pitched screaming cry, sometimes for as long as five hours.

Stephanie also cried almost every night, because the mom of four knew this wasn't how parenting was supposed to feel. "On the really bad days, I just prayed for his bedtime to come," she said. "I felt like a failure as a mother."

Oakland Family Services' Early On had resolved the now 3-year-old's developmental delays, which stemmed from his birth mother's drug use during her pregnancy. But, one thing became clear – he was still very angry and aggressive, especially with Stephanie, who felt isolated and alone. Though her husband, Barrett, supported and sympathized with her, he did not face the same obstacles with DiMario, whom the couple has now officially adopted.

The family was referred to Oakland Family Services' Fussy Baby program, a home-based program for families with a child (birth through 3 years old) exhibiting difficulties with self-regulation, such as inconsolable crying, inability to self-calm, difficulty sleeping, eating, and behavior difficulties. Stephanie was excited, overwhelmed and nervous when she started in the program.

"I shouldn't have worried," she said. "Our Fussy Baby worker came to our home and hit it off with DiMario so incredibly fast, which is a very hard thing to do."

Their worker gave Stephanie suggestions for one-on-one time with DiMario, where he was in charge of decision-making regarding play. She taught her how to help DiMario soothe himself, especially at bedtime, which always triggered tantrums. She also assisted Stephanie in realizing the motivation for DiMario's behavior.

"She helped me see that, underneath it all, he was just a hurt little boy," Stephanie said.

Stephanie was overjoyed when, after time, she was able to soothe DiMario, all on her own. In fact, she said the first night she was able to put DiMario to bed successfully, she texted all her friends and family to share the happy news. The Fussy Baby program gave Stephanie's whole family a new beginning. She said that everyone feels it – not just her and Barrett, but also their two daughters, Stella and Quinn, and their other adopted son, Giovanni.

"My whole household is so much more peaceful since we found Oakland Family Services and the Fussy Baby program," she said. "DiMario is a silly, playful kid and I am so glad I can enjoy that now. I am so thankful to Oakland Family Services for the help we received during this trying time in our lives. If I had not had the agency's help, and our Fussy Baby worker walking through this with me, I do not think we would have seen any improvement fast. My family and I would have missed out on a lot of quality time together just struggling through it. But instead, Oakland Family Services helped my son feel better, gave me the tools to be a more effective parent, and improved the future for us, as mom and son."

Night+day from last year

EDUCATION

Tanith and Darius were so excited to send their son Rahket to preschool at Oakland Family Services in the fall of 2015, but right from the start, the classroom environment was proving difficult for him.

Rahket was having terrible tantrums, screaming at the top of his lungs for at least five minutes at a time. He would lash out at other children, hitting them if they cried. He was throwing things, kicking and was unable to play with other kids.

The staff at the Children's Learning Center had to contact Tanith and Darius about Rahket's behavior nearly every day during the first few weeks of school. In order to help them understand the sensory issues he was experiencing, the staff showed Tanith and Darius a video of their son interacting in the classroom. The video shocked them.

"I felt defeated and wondered, 'Did we do something wrong?" said Darius.

"I was shocked to see that and how aggressive he was," said Tanith. "I said, 'If he's attacking people, I'm going to keep him home.' It was a very sad day."

The staff at the Children's Learning Center encouraged Tanith and Darius to do anything but take him out of school. Instead they explained they were there to work through the sensory issues Rahket was having, along with his family.

Tanith and Darius explained that Rahket's behavior outside of school started to make sense to them, when looking at it through the lens of sensory and social development issues. He would cry at church when the instruments were loud and he wouldn't play with the neighborhood children.

"It was painful watching him interact," said Darius.

The Children's Learning Center staff worked very closely with Tanith and Darius to ensure that Rahket succeeded. They helped educate them about Rahket's sensory needs, connected them to necessary resources, offered them methods to calm him, and also taught Rahket coping skills for handling sensory triggers in the classroom. "They said, 'We are going to keep working with him. We are going to help him,'" said Tanith. "They could have put him out."

That work has ensured Rahket is successful in the classroom and will enter kindergarten ready to learn. That is the goal for all students at Oakland Family Services' two Children's Learning Centers, which each offer a high-quality education for 96 students. Tanith and Darius said if they had not placed Rahket in the Children's Learning Center for preschool, he would have been unsuccessful in kindergarten, not academically, but socially.

Rahket has made huge progress in his interactions and behavior in the classroom. He has learned how to process his feelings. For example, when he hears a classmate crying, instead of hitting the child, he asks if he or she is OK.

"The staff at the Children's Learning Center never tell you what to do, or point a finger," said Tanith. "They are there to assist you with your child's growth. I feel very proud now. I am so happy."

"He's like night and day from last year," said Darius. "The staff is equipped to deal with any issues because they are patient and they really care. They are passionate about working with children. We still have some things to work on, but now I know my son will be OK."

INTRODUCING: DAY ONE

As a result of the work done in 2016, the new beginnings that we offer our clients will also mean a new beginning for Oakland Family Services' Behavioral Health program in the coming year, as we unveil its new name: Day One.

The name reflects the idea that Oakland Family Services has resources and commitment to current and future clients, when they want to start fresh, to begin, or even to begin for the 10th time creating the life they want for themselves.

Those surveyed regarding the new name had a positive reaction to it, citing "happy," "happiness," and "hope" as the words they most associate with it. "Day One is a step forward," read the feedback from one client. "Understanding each day is a new day to go in the right direction of thought, action and deed... For me, it is happiness."

Received a new beginning

TREATMENT

Victoria's life began with what her adoptive parents call a hurtful broken promise. When Victoria was 6 years old and in foster care, her birth mother told Victoria she would bring her home, but instead chose her partner over her daughter.

Victoria's father had slipped through the cracks and her birth mother waived her right to say goodbye. When a social worker told Victoria she would never see her mother again, Victoria began having night terrors and screaming in her sleep.

Debra and Mark, who had been providing respite care for Victoria while she was in foster care, adopted Victoria and though they were so happy to be able to provide Victoria the life she deserved, they watched her drowning in the sense of abandonment from her mother's rejection.

"We certainly felt terrible for what she had gone through and wanted her to embrace her new family," said Debra.

Victoria was diagnosed with Reactive Attachment Disorder (RAD), a condition that leaves children unable to form attachments or relationships with a parent or caregiver after their basic needs are not met or their emotional needs are ignored in early life. However, despite seeing three different therapists in the years following her adoption, it was clear they were not gaining ground.

"As a parent, all you want to do is fix things," said Debra. "They say love fixes things, but it wasn't. We couldn't help her. We needed help... we all needed help. I called Oakland Family Services and said, 'You've got to help us. We adopted this little girl and we love her and she can't be happy."

Mark, Debra and Victoria were referred to Oakland Family Services' Specialized Services for Youth program, where she was provided with group and one-on-one therapy. Specialized Services for Youth is a program for families with a child or adolescent, ages 6-17, suffering from severe emotional, behavioral and/or psychological stress.

"I was in seventh grade," said Victoria. "I was not sleeping. I was doing awful. I was stealing from my family members. It was a downward spiral... months and months of it."

Victoria said her therapist immediately made her feel understood.

"She talks to me like I am a person, a fellow human being, not a patient or a problem child," said Victoria, who is now 13 years old.

Debra and Mark were also provided with the support of a certified parent support partner from Oakland Family Services, to help them understand and work with their daughter's RAD.

"We needed her assistance in order to be better parents," Debra said. "Instead of thinking we have a child who is rebellious, now we know what she is going through. From when she was 0-6, any adult who had been in Victoria's life had let her down. She's doing this because she is scared. Now we understand that that is an internal fear that we need to heal. This program has been phenomenal."

Mark said the key has been Oakland Family Services' staff.

"Other therapists sat behind a desk authoritatively and spoke at us," he said. "Our Oakland Family Services therapist sat with us. She was on our team."

Victoria received a new beginning because of Oakland Family Services. Though she still deals with the trauma of her early life, her family life is much more peaceful and she is doing well academically. She said she is so far away from when she felt like everything had crumbled around her.

"I've actually gotten better," she said. "I can actually function. I can have a relationship with my parents. My birth mom abandoned me and that's a special kind of sting, but I've been able to get over that more and get on with my life."
